



MEMORANDUM OF UNDERSTANDING

Between:

Namik Kemal University, Tekirdağ, Turkey represented by Rector Prof. Dr. Osman ŞİMŞEK

and

UNIVERSITY "KADRI ZEKA" GJILAN
Gjilan, Republic of Kosovo
represented by Rector Prof. Assoc. Dr. Bajram Kosumi

Preamble:

Namik Kemal University and University "Kadri Zeka" in Gjilan (hereinafter referred to as "Parties") wishing to establish cooperation in promoting academic, educational, and cultural cooperation between the two institutions, in the terms stated henceforth, have concluded the present Agreement of Cooperation.

This Agreement will be developed within the framework for institutional cooperation, and will facilitate further development and consideration of specific programs of cooperation of mutual interest for both Parties, especially in the common interest in the development of research and teaching.

Article 1

Both signatories determine and regulate with this agreement the areas and matters of mutual cooperation as well as the forms and manners of its implementation.

Article 2

Signatories shall co-operate in the following areas:

- On deepening the current cooperation for Erasmus + projects, Horizon 2020 and Mevlana Program and other international projects;
- Of organizing and carrying out undergraduate and graduate education and the exchange of experience and information on study programs, methods and didactic procedures in the specially agreed upon study and scientific fields;
- Of faculty and student exchanges;
- Of organizing and carrying out joint research projects and mutual exchange of information on research results;
- Of teaching and research faculty development;
- Of the mutual exchange of information on academic activities and planned university development;
- Of the exchange of all publications published by universities and important for the development of scientific and educational activities;
- Of mutual library cooperation and exchange of books, periodicals and other information material;
- Of cooperation of students and student organizations in the field of academic, cultural and sport activities;
- Of information exchange and coordination of admission requirements for undergraduate and graduate studies;
- Of publishing;
- Of organizing and participating in scientific and professional meetings, conferences, symposia and other forms of education;
- other areas in which mutual interest in cooperation is established.

Article 3

Both signatories as per accord agree that the cooperation shall be carried out on the basis of a yearly program of cooperation.

Both universities shall agree upon the forms and manner of cooperation.

Article 4

The inter-university cooperation based on this agreement shall be carried out on the principle of reciprocity.

Article 5

All details and the realization of the individual activities defined by this agreement shall be discussed and adjusted by both signatories.

Article 6

Both signatories shall consent to mutually inform each other about all circumstances important for the realization of this agreement

Article 7

All possible amendments and additions to this agreement as well as other questions related to the subject of this agreement shall be concluded in writing and annexed to this agreement.

Article 8

This agreement shall be concluded for an indefinite period of time. Each university may cancel the agreement in writing; the cancellation period shall be six months in advance. This agreement shall cease to apply at the end of the cancellation period, provided that the annual program of cooperation has been carried out.

Article 9

The agreement shall go into effect when signed by the legal representatives of both universities. It is signed in two copies, where all have a nature of the original and where each signatory receives one copy.
